Re: Your March 15, 2017 letter

Dear Director Churchwell:

I am writing in response to your March 15, 2017 letter concerning the list maintenance program prescribed by the federal National Voter Registration Act. More specifically, you have requested that the Commissioner of Registration for Cumberland County (the "Commissioner") allow inspection (or provide copies) of documents concerning voter registrants in Cumberland County whose United States citizenship has been drawn into question based on information obtained from any source since 2009.

For ease of reference, I have repeated below each of the four requests you have made, with the Commissioner's response to each request appearing immediately below the request.

Request #1. Documents regarding all registrants who were identified as potentially not satisfying the citizenship requirements for

registration from any information source, including information obtained from the New Jersey Motor Vehicle Commission or from the New Jersey Department of State since 2009. This request extends to all documents that provide the name of the registrant, the voting history of such registrant, the nature and content of any notice sent to the registrant, including the date of the notice, the response (if any) of the registrant, and actions taken regarding the registrant's registration (if any) and the date of the action. This request extends to electronic records capable of compilation.

Response #1. Copies of the documents responsive to your request are enclosed.

Request #2. All communications regarding your list maintenance activities relating to #1 above to the County Prosecutor(s), New Jersey Attorney General, New Jersey State Police, any other state law enforcement agencies, the United States Attorney's office, or the Federal Bureau of Investigation.

Response #2. The Commissioner's office does not have any records that are responsive to your request.

Request #3. The total voting-age population in your jurisdiction as of the date of your response.

Response #3. The Commissioner's office does not maintain any records that are responsive to your request. You may find information about the County's voting-age population on the website of the United States Census Bureau at www.census.gov.

Request #4. The total number of voters registered in your jurisdiction as of the date of your response.

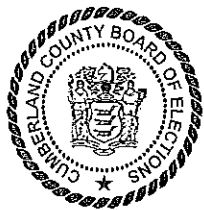
Response #4. The total number of registered voters in Cumberland County as of August 25, 2017 is 89385.

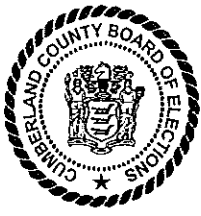

Note: ID Numbers are Confidential and will not be released by any governmental agency. Any person who uses such numbers illegally shall be subject to criminal penalties.
- If you are homeless, you may complete section 6 by providing a contact point or the location where you spend most of your time.
- You may declare a political affiliation or you may declare to be unaffiliated, regardless of any prior party affiliation. Completing section 10 is OPTIONAL and will not affect the acceptance of your voter registration application.
