Voting falsly is a federal offense. I reccomend talking with your solicitor if it comes to that.

Molly,

I need some info on 2 cases. Perhaps you can help.

I have a provisional voter who was in the district register but the signatures were way off so the judge challenged it as the voter had no ID.

The judge called while the voter was still at the poll and said she did not believe the voter was who she claimed as she also appeared much younger. The voter wanted to void her provisional and vote on the machine. I told her the judge had the final say.

Could you find out if 'PenDOT' has a signature on file for Lisa (8/26/63, at Aspinwall PA 15215) so that we can make a determination whether to count the ballot?

The second case involves a possible non citizen who registered to vote through PenDOT.

(We've cancelled 3 or 4 non citizens this year who were DOTIA's)

A very concerned voter called today as a co-worker, John claimed (was bragging about) his wife who is not a citizen was able to vote.

11/17/2008

I checked the records and Fusako 10/18/69, voted and was registered through a DOTIA dated 5/22/07.

Does PenDOT have citizenship requirements for DL's , if not, are applicants asked If they are citizens?
If PenDOT does not know if she is a citizen is there another state agency that can help?

Thanks for your prompt attention to these matters.
