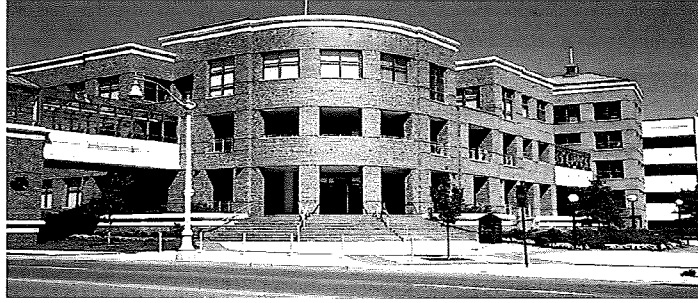

Dear Director Churchwell:

We are writing in response to your March 15, 2017 letter concerning the list maintenance program prescribed by the federal National Voter Registration Act. More specifically, you have requested that the Commissioner of Registration for Ocean County (the "Commissioner") allow inspection (or provide copies) of documents concerning voter registrants in Ocean County whose United States citizenship has been drawn into question based on information obtained from any source since 2009.

For ease of reference, we have repeated below each of the four requests you have made, with the Commissioner's

response to each request appearing immediately below the request.

Request #1. Documents regarding all registrants who were identified as potentially not satisfying the citizenship requirements for registration from any information source, including information obtained from the New Jersey Motor Vehicle Commission or from the New Jersey Department of State since 2009. This request extends to all documents that provide the name of the registrant, the voting history of such registrant, the nature and content of any notice sent to the registrant, including the date of the notice, the response (if any) of the registrant, and actions taken regarding the registrant's registration (if any) and the date of the action. This request extends to electronic records capable of compilation.

Response #1. Copies of the documents responsive to your request are enclosed.

Request #2. All communications regarding your list maintenance activities relating to #1 above to

the County Prosecutor(s), New Jersey Attorney General, New Jersey State Police, any other state law enforcement agencies, the United States Attorney's office, or the Federal Bureau of Investigation.

Response #2. The Commissioner's office does not have any records that are responsive to your request.

Request #3. The total voting-age population in your jurisdiction as of the date of your response.

Response #3. The Commissioner's office does not maintain any records that are responsive to your request. You may find information about the County's voting-age population on the website of the United States Census Bureau at [www.census.gov](http://www.census.gov).

Request #4. The total number of voters registered in your jurisdiction as of the date of your response.

Response #4. The total number of registered voters eligible to vote in Ocean County as of August 23, 2017 is 399,649. This number does not include 17 year old pending registrants who have not yet turned 18. The total of pending 17 year olds is 1,564.

### TIME FRAME FOR RESPONSE TO A REQUEST

The Custodian of Records is required to grant or deny access to a government record no later than seven (7) business days after receiving the request. If you do not provide a name, address, telephone number or other means of contacting you, the Custodian of Records will be unable to respond until you reappear in the Custodian of Records' Office seeking a response to the original request.

If the government record is in storage or archived, you will be so advised within seven (7) business days after the Custodian of Records receives your request. You will be advised by the Custodian of Records when the record can be made available. If the record is not made available by that time, access will be considered denied.

### RIGHT TO APPEAL

If you wish to challenge a decision of the Custodian of Records denying access to a government record, you may:

- 1) Institute a proceeding to challenge that decision by filing an action in Superior Court in New Jersey; or
- 2) File a Complaint with the Government Records Council in the Department of Community Affairs.

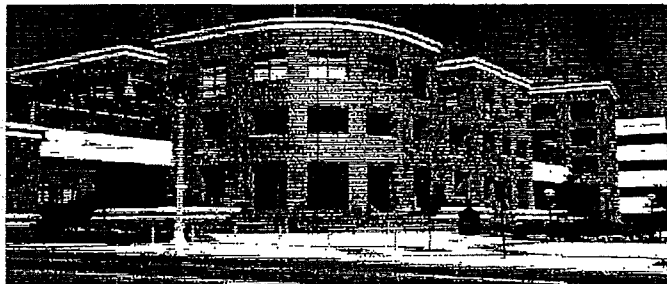

Dear Mr. DiSimoni:

The Government Accountability Office (GAO) report (GAO-05-478) identified the federal judiciary as a potential data source for notifying state election officials of individuals who claim to be non-citizens for verifying voter registration eligibility. GAO recommended that the federal courts assist state election officials to assure that voter lists are accurate.

Pursuant to that recommendation, and in accordance with provisions in our jury plan, I am enclosing a list of persons who have identified themselves to us as non-citizens through our juror qualification process. The list provides the names of those potential jurors who have responded negatively to the question on citizenship status on our qualification questionnaire.

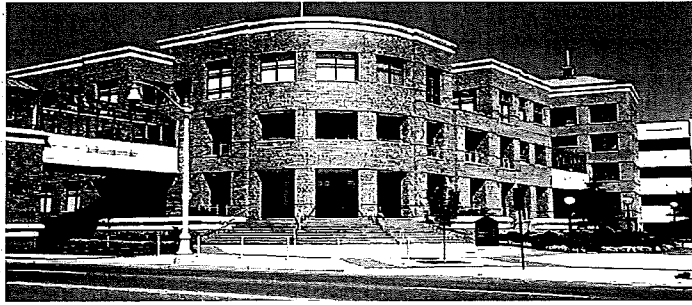

As discussed, attached below please find letter and copy of passport identification received from David Petty; 10/31/1961; 1206 Koa Dr. Forked River NJ 08731. He is currently a registered voter in Ocean County who appeared on a list provided by the US District Court containing individuals who identified themselves as a non-citizen through the juror qualification process. The list was forwarded to our office by the NJ Division of Elections. Mr. Petty stated that he did not recall ever filling out such forms indicating that he is not a US citizen and that he is a US citizen. He came in to our office today to provide a letter documenting his statement and a copy of his passport. It may be tough to read but the issue date of the passport is May 28, 2008; expires May 27, 2018. We informed him that this matter would also need to be addressed with the US District Courts. He provided a phone contact number of 609-203-5754.
