Your Wisconsin Elections Commission request number (21716) is updated with the information below.

Dear Mr. Churchwell,

After applying the new date range described below, January 1, 2023, to February 9, 2023, there were 902 potentially responsive records. Next, I will review the records and determine whether or not they are responsive to your request concerning Election Day Registration postcard guidance. I believe this will eliminate a significant number of records containing terms such as "guidance" or "returned undeliverable" that do not involve Election Day Registration postcard guidance. For example, around 220 emails are simply automatic return messages related to emails sent to undeliverable email addresses.

After determining which records are responsive, I will review each email to determine whether any email is a privileged communication or otherwise subject to withholding or redaction under Wisconsin's public records law. Given the number of records and the fact that the Spring Primary is next week, which will demand most of my time next week, it is not likely that responsive records will be ready for transmission by February 27. You arriving in Madison will not affect the amount of time needed to perform these tasks, and these records will be emailed to you when they are ready to be released, regardless of your appearance in our office.

Mr. Hunzicker:

We received your response dated November 15, 2023. Your response indicates that you will not perform a search for responsive records unless we provide (1) a "time range" for the request, and (2) "specific search terms."

Wisconsin law provides that a request "is deemed sufficient if it reasonably describes the requested record or the information requested." Wis. Stat. § 19.35(1)(h). However, "a request for a record without a reasonable limitation as to subject matter or length of time represented by the record does not constitute a sufficient request." Id.

Our request "reasonably describes the requested record[s]" with a "reasonable limitation as to the subject matter." *Id*. The requested records concern an identifiable guidance document with a specific date and subject matter—namely, Election Day Registration postcards. There is thus no ambiguity with respect to the subject matter. Furthermore, the guidance document itself provides numerous other search terms.

While the request does not provide a "length of time" governing the request, such a time is inherent in the request due to the subject matter and specific date of subject document. Whatever ambiguity may exist regarding the outer bounds of the governing time period, it is not so ambiguous as to relieve WEC of its duty to search for responsive records. Furthermore, "the fact that the request may result in the generation of a large volume of records is not, in itself, a sufficient reason to deny a request as not properly limited." State ex rel. Gehl v. Connors, 2007 WI App 238, ¶23.

Notwithstanding the foregoing, we are providing additional information to help assist WEC with its search for response records.

I apologize for missing your requests for updates. I was not receiving notifications in our public records system, and I did not see your messages and messages from several other requesters.
