RE: Necessary Collaboration Between Your Offices

Dear Secretary Noem and Administrator DeMarinis:

On behalf of the Public Interest Legal Foundation, I write to recommend that Maryland and DHS administrators for the SAVE system finally begin collaborating in light of new disclosures in the **Ian Andre Roberts** case. The Public Interest Legal Foundation ("Foundation") is a nonpartisan, nonprofit, public-interest law firm dedicated exclusively to election integrity.

Prince George's County disclosed Mr. Roberts unredacted file to the Foundation this morning, revealing that, on at least two occasions, he apparently claimed U.S. citizenship in applying for regular voter registration. Maryland could have prevented this had it used SAVE for voter registration verification when the Obama Administration first offered it. It is incumbent on Maryland and DHS work together to protect citizens and immigrants alike.

¹ The Foundation distinguishes regular voter registration (capable of voting in any election) from voting rights extended to foreign nationals under Maryland law, like offered by the Cities of Greenbelt and Hyattsville.

Administrator DeMarinis, as you know, SAVE was dramatically improved in April 2025² and again in November³ when DHS began allowing queries with the last four digits of a Social Security number. Today, the data collected on a standard Maryland voter registration form⁴ is all that is required for a successful SAVE query. It has never been easier for Maryland to adopt this tool.

Secretary Noem, the Foundation trusts that administrators for the SAVE system stand at the ready to welcome the Maryland State Board of Elections, just like that state's Department of Human Services⁵ before them. Perhaps a formal invitation is needed to get the Board of Elections started.

Elections office staffers in Prince George's County had no option but to accept Mr. Roberts' claims to U.S. citizenship as true without a tool like SAVE. It's simply unacceptable to millions of Americans for this pattern to repeat. The Public Interest Legal Foundation commends DHS's leadership in bettering SAVE, and we hope Maryland leaders now rise to meet this opportunity for improvement. Thank you for your attention to this matter.
